FLORA WEBSTER PATTERSON/ LOU TURI SCHOLARSHIP FUND

Eligibility:

Scholarships will be awarded to OPEIU, Local 32 members and/or their dependents. Applications are open to members in good standing and their dependents.

All applicants must meet the eligibility requirements and comply with the Rules and Regulations as established by the OPEIU, Local 32 Scholarship Committee. Each scholarship has a value of \$500.00.

The applicant must be:

- a member in good standing of OPEIU, Local 32, or the dependent of a member in good standing; and
- currently attending or plan to attend a college, university, or technical/vocational post-secondary education school as an undergraduate or graduate student

Procedures:

Each applicant must file an official Flora Webster Patterson/Lou Turi Scholarship Fund application. Application forms must be endorsed by the Local 32 President or Secretary-Treasurer attesting that the member.

Forms:

Application forms may be obtained from your shop steward, by calling the Local 32, OPEIU office at I 800 281 -4550, or on our website www.opeiu32.org.

Requirements:

High School Transcript or GED:

All applicants are required to submit their High School transcript or GED.

Rank in Class:

The High School transcript must show rank in class or rank in class must be provided. In the event the High School does not rank students, approximate rank or percentile and class size must be provided.

College Transcript:

If presently enrolled in a College, University or a recognized Technical or Vocational Post-Secondary School, applicant is required to submit College transcript, along with their High School Transcript.

Essay:

All applicants are required to submit an essay on their occupational goals (300 to 500 words). This essay should be double-spaced and typed on 8 ½ " x 11" paper.

Applications and Requirements:

All applications, High School Transcripts, Rank in Class or approximate rank or percentile and class size, College Transcripts (if applicable) and essays must be received at the OPEIU, Local 32 office, 3350 Hwy 138, Bldg. 2, Suite 125, Wall, New Jersey 07719 no later than March 31st of each year.

Selection of Scholarship:

The selections shall be based on the recommendations of the Local 32, OPEIU Scholarship Committee. The announcement of the winners will be made during the month of June in each year.
